Delhi-Mumbai Industrial Corridor set to transform India with USD 100 billion investment

The Delhi-Mumbai Industrial Corridor (DMIC), spanning 1,504 kilometers across six states, is India's largest infrastructure project with a USD 100 billion investment. Launched in collaboration with Japan in 2008, the DMIC aims to double employment, triple industrial output, and quadruple exports in the region within five years of full operation. Covering 436,000 sq. km, it integrates nine industrial zones, smart cities, high-speed freight lines, and new ports. Key projects like Gujarat's Dholera SIR and Maharashtra's Shendra-Bidkin are advancing, emphasizing sustainability and modern urban planning. Despite challenges like land acquisition, DMIC is poised to reshape India's industrial and economic landscape.

The Delhi-Mumbai Industrial Corridor (DMIC) is an ambitious infrastructure project aimed at creating a worldclass industrial zone along a 1,504-kilometer stretch between Delhi, the national capital, and Mumbai, India's financial hub. Spanning six states-Uttar Pradesh, Delhi NCR, Haryana, Rajasthan, Gujarat, and Maharashtra-the project is designed to enhance industrial growth, foster urbanization, and position India as a global manufacturing and trading hub. With an estimated investment of USD 100 billion, the DMIC is one of the largest infrastructure projects in the world, promising to reshape India's economic landscape.

The origins of the DMIC can be traced back to 2006, when the governments of India and Japan signed a memorandum of understanding to collaborate on the project. The corridor aligns with the Western Dedicated Freight Corridor (DFC), a high-speed rail network that facilitates efficient movement of goods. The DMIC project was formally launched in 2008 with the establishment of the Delhi Mumbai Industrial Corridor Development Corporation (DMICDC), tasked with planning and implementing this transformative initiative.

The project spans a corridor of 150-200 kilometers on both sides of the DFC, covering a total area of approximately 436,000 square kilometers. This region accounts for nearly 14% of India's land area and contributes a significant portion of the country's industrial output. The DMIC aims to double employment potential, triple industrial output, and quadruple exports from the region within five years of becoming operational. By integrating advanced infrastructure with industrial development, the DMIC is expected to make India a global hub for manufacturing, logistics, and exports.

The corridor encompasses several key components, including nine mega industrial zones, high-speed freight lines, three new ports, six greenfield airports, and a six-lane expressway connecting Delhi and Mumbai. These infrastructure projects are complemented by state-of-the-art utilities, including a 4,000 MW power plant and water supply systems to meet the demands of industrial and residential developments. Additionally, the DMIC emphasizes the development of smart cities with integrated townships, offering modern amenities and sustainable urban planning.



Gujarat government seeks
Rs 40,783 crore grant from
Centre for semiconductor industry
development in
Sanand and Dholera SIR

The Gujarat government's Department of Science and Technology has sought Rs. 40,783 crore from the Government of India to develop the semiconductor industry in Sanand and Dholera SIR over the next six years.

AHMEDABAD: Department of Science and Technology Gujarat government has demanded substantial Rs 40,783 crore grants from the government of India (GOI) for the development of semiconductor industry in Dholera SIR region and Sanand near Ahmedabad in next six years.

Mona Khandhar, principal secretary, science & technology department informed that, "the objectives of the state government is of robust and sustainable semiconductor and electronics ecosystem in Sanand and Dholera SIR region in next six years."

"Of the five semiconductor facilities approved by the GoI under the Semicon India programme, four projects are being set up in Gujarat. A chip packaging cluster is taking shape in GIDC Sanand with major projects by Micron Technology Inc, CG Semi and Kaynes Semicon. India's first commercial semiconductor fab is being set up in Dholera SIR by TATA Electronics Pvt. Ltd. Furthermore, the Government is actively engaging with multiple ecosystem partners and several project proponents considering to set up their manufacturing units in Gujarat. The establishment of these strategic projects in the state poses a distinctive opportunity to establish Gujarat firmly on the global semiconductor supply chain by focusing on facilitating development of the ecosystem of suppliers. Infrastructure Development requires significant development and upgrading of industrial infrastructure, including utilities, logistics, and security systems, to meet global standards. Establishing a robust ecosystem of suppliers is crucial for supporting the semiconductor industry. This requires coordination among various stakeholders. Workforce development also remains a significant challenge and requires additional financial resources," Khandhar said.

Khandhar further added, "establishment of specialised manufacturing clusters in Sanand and Dholera that provide plug-and-play utilities, allowing companies to scale operations quickly and efficiently. Long-term sustainable growth of the economy driven by the semiconductor sector, contributing to GDP and regional development. Enhanced integration of Gujarat's semiconductor ecosystem into global supply chains, facilitating trade and collaboration with international markets. Enhanced Security and Logistics frameworks ensure the safety and efficiency of semiconductor operations and transportation. Positioning Gujarat as a significant player in semiconductor exports, boosting the state's international trade projected funds requirement will be around Rs.40,783 crore in next six years. We have requested the national finance commission and the government of India for special grants.



Dholera Airport to see international air cargo operations later this year; DIACL initiates preparations

Japan K Pathak, Gandhinagar: Upcoming Dholera airport may start operations later this year exclusively by handling international air cargo operations through freighter flights/passenger flights.

Dholera International Airport Company Limited(DIACL) intends to commence international air cargo oeprations in initial phase from June/July 2025. Upcoming Dholera airport is located at around two hours distance from the city of Ahmedabad. The works for construction of a greenfield expressway to Dholera airport and Dholera are progressing in advanced stage.

DIACL has already invited tenders from the contractors for operation and management of international cargo terminal & ground handling services at Dholera Airport for a period of 7 years. Bids shall open in the month of March this year. DIACL has stated that it intends to commence international air cargo operations in initial phase from June/July 2025.

DIACL is a Special Purpose Vehicle (SPV) established by the Government of Gujarat (GoG), with equity participation from Airports Authority of India (AAI) – 51%, Government of Gujarat – 33%, and National Industrial Corridor Development and Implementation Trust (NICDIT) – 16%, for the development of Dholera International Airport as a greenfield airport to meet the logistics requirements of the Dholera Special Investment Region.

A total area of Air cargo Terminal according to DIACL is 10,700 sqm approx. (International Cargo) Built up area is 2,450 sqm (only Ground Floor), paved area is 8,800 sqm and 4260 Sqm airside ramp area will be provided for carrying out cargo handling.

A category 4E - 06L - 24R runway shall be 3200 Mtr. long with provision of two parking stands and equal






